**TOURNAMENT RULES and REGULATIONS**  
**TOURNAMENT START DATE: FEB 5<sup>TH</sup>, 2022 ~ END DATE: FEB 20<sup>TH</sup>, 2022**

**1. ELIGIBILITY**

- 1a. Entrants must be a current adult woman's member of USBC and the Greater Central Connecticut USBC Association, with a minimum of 21 games bowled in GCCBA by January 24, 2022, over the age of 17, and no longer in high school, by January 24, 2022. Any bowlers holding a PBA/PWBA membership card are eligible to bowl in this tournament with the following provisions: Only one card holder will be allowed to bowl on a doubles team and no more than two card holders will be allowed to bowl in the team event.
- 1b. NO entry money will be refunded for failure to comply with all rules and eligibility requirements of the USBC and this tournament. "Falsification of average is subject to disqualification"
- 1c. Any four members of the GCCUSBC may enter the team event.
- 1d. Any two members of the GCCUSBC may enter the doubles event. Note: Rule 4a.
- 1e. Entry fee ***MUST*** accompany the Entry Blank.
- 1f. Dress code Will Be Strictly enforced. See back page.
- 1g. **WARNING TO YOUTH BOWLERS:** You may jeopardize your amateur status by bowling in this tournament or any other tournament where cash prizes are awarded.

**2. RULES**

- 2a. Tournament will be bowled in strict accordance with rules adopted by USBC and the GCCUSBC. USBC National Rules of Tournament will cover any rule not covered herein. If an entrant fails to comply with all rules, she and the entire team will be disqualified.
- 2b. The entry fee for the tournament is \$30.00 per person, per event.

**3. HANDICAP and AVERAGES**

**HANDICAP will be 100% of 220.**

- 3a. Entrants will use their highest USBC sanctioned league average for the 2020-2021 season with a minimum of 21 games. Winter averages will be used. If no winter average is available with a minimum of 21 games, summer average will be used as long as a minimum of 21 games have been completed. If a bowler has no average for the 2020-2021 season, the highest USBC sanctioned league average for the 2019-2020 season with a minimum of 21 games will be used. If no winter average is available with a minimum of 21 games, summer average will be used as long as a minimum of 21 games have been completed. If no average with a minimum of 21 games from the prior two seasons, current highest league average as of January 24<sup>th</sup>, 2022 with a minimum of 21 games will be used. This tournament does follow rule 319E. Average cut-off date for "10-pin" rule will be in effect as of January 24<sup>th</sup>, 2022. Entering average of bowlers first appearing in tournament will continue to have same average throughout tournament. Requirement for completion of average verification form is required. If your only average is from a sport league it will be adjusted to the scale as per rule 201a.
- 3b. Rule 319d does apply for this tournament which states:  
Within the last 12-month period, anyone who has qualified for a cash and/or merchandise prize in the position standings prize list in a tournament, including all-events, special features, special prizes, and donated prizes, must give tournament management the following information prior to participation for possible average adjustment:
  - A. The name of each tournament in which they have been paid the following prizes, or if not yet paid, in which they have qualified for the prize:
    - 1) \$300 or more in any event;
    - 2) Total combined prize winnings of \$500 or more in any one tournament;
    - 3) Total combined prize winnings of \$1000 or more in all tournaments within the last 12-months;
  - B. The amount of the prize;
  - C. The actual score bowled to qualify for the prize;
  - D. The prize position.
- 3d. All entrants should read Rule 319e.
- 3e. Rule 319a, Item 3 - Bowlers are responsible for verifying her own average whether submitted by the bowler, the team Captain or others.
- 3f. **TOURNAMENT MANAGEMENT RESERVES THE RIGHT TO ADJUST ANY AVERAGE, AS THEY DEEM NECESSARY.**

**4. MULTIPLE ENTRIES**

- 4a. Contestants may enter Multiple Times. However, for team event, not more than two (2) original members. If you re-enter doubles at least one player must be different.
- 4b. Walk-ins will be accepted for Team, Doubles, or Singles. (Subject to lane availability)
- 4c. In singles event, the same individual may not place more than once.
- 4d. **BOWLERS MAY ENTER THE DOUBLES AND SINGLES EVENTS MORE THAN ONCE. YOUR FIRST DOUBLES AND SINGLES WILL COUNT FOR YOUR ALL EVENTS.**
- 4e. Walk-ins must be signed up 30 minutes before the squad time.

**5. ALL-EVENTS (OPTIONAL)**

**5a. A bowler's first appearance in the team, doubles & singles event shall count towards the All-Events total.**

**5b. There will be two (2) divisions: All-events with handicap and All-events scratch.**

**5c. Only those entrants who pay the fee qualify for all-events cash prizes. The fee is returned 100% in prizes. One prize will be paid for at least one in (8) eight entries. Fee must be paid prior to the bowler's first throw in their first event.**

**6. RE-ENTRIES AND WALK-INS**

**Walk-ins will be accepted for team, doubles & singles, subject to lane availability and must sign up and check in 30 minutes prior to squad time.**

**7. PRIZES**

**Prize fee will be returned 100% in prizes. One prize will be paid for at least eight (8) entries in the team, doubles, and singles events. Prize moneys will be paid within 30 days after the tournament ends. Awards will be given to handicap champions.**

**8. TIES**

**Ties for first place shall be bowled off at a time designated by the tournament director. Prize money for all other ties will be equally divided among the positions tied. One game roll-off shall be bowled to resolve a tie in all divisions. Any still remaining ties will be resolved with a ninth and tenth frame roll-off.**

**9. PROTESTS**

**Protests must be reported to the Tournament Director within 72 hours. See USBC Rule 329.**

**10. TARDINESS**

**Tardy players will start in the frame being bowled with zero being scored for each frame missed.**

**11. DRAW FOR LANES**

**All three (3) games in each event will be rolled on the same pair of lanes. These lanes will be assigned by the tournament committee members.**

**12. Any problem not covered by the rules stated above or on the face of the entry form will be governed by the rules of the UNITED STATES BOWLING CONGRESS.**

**13. CHECK IN**

**All bowlers are required to check in at the tournament to verify dress code and attendance. NO EXCEPTIONS**

**14. Brackets will be available on the THIRD AND FINAL WEEKEND OF THE TOURNAMENT ONLY.**

# **TEAM CAPTAINS**

The following dress code will be in effect for this tournament and will be **STRICTLY** enforced.

## **TOURNAMENT DRESS CODE**

- Participants must wear a shirt with a polo type collar, mock neck collar, or crew neck shirt. Bowling apparel shirts will be allowed as long they meet requirements listed above. No t-shirts allowed.
- Women may wear skirts, slacks, casual trousers, skorts, culottes, capris, or denim jeans. Capris will be allowed provided the length is below the knees and at least mid-calf or longer. Leggings will only be allowed with no visible undergarments. Skirts/skorts must be at least fingertip length when standing with arms down at sides and the garment's outer material must be at least half the distance of the upper leg. Shorts will be allowed as long as they are presentable with no holes, or cut offs.
- All clothing must be neat, clean and have no holes or tears.
- Clothing not allowed are as follows: Sweatshirts and sweatpants, parachute (Warm up) pants, leggings separately, yoga pants, hats, and t-shirts. No profanity or vulgarity will be allowed on any clothing, including bowling jerseys.

**All dress code is up to the discretion of tournament management.  
Decision will be final.**

## **700 MINI TOURNAMENT**

- ❖ Any bowler who has ever thrown a 700 series in any GCC sanctioned league or tournament may enter this optional tournament.
- ❖ The cost to enter will be \$10.00 – with 100% of the entry money being returned to the bowlers of this tournament.
- ❖ The All Events scores (raw score plus handicap) of the main tournament will be used to determine the winner(s) of the 700 Tournament.
- ❖ All other rules of the main tournament shall apply.
